

RECONSTITUTION OF COMMITTEE OF CREDITORS ON THIS 05TH DAY OF NOVEMBER 2024 IN THE MATTER OF M/S GRANDSTAR REALTY PRIVATE LIMITED HAVING ITS REGISTERED OFFICE SITUATED AT H-65, CONNAUGHT CIRCUS, NEW DELHI -110001 AND PROJECT SITE LOCATED AT SECTOR M-1, VILLAGE LAKHNAULA, MANESAR, GURGAON-122052

Whereas Hon'ble National Company Law Tribunal, New Delhi, Bench V vide its order CP (IB) No. 995/PB/2020 dated 26.09.2023 appointed Mr. Jalesh Kumar Grover as Interim Resolution Professional ('IRP') of the Corporate Debtor, M/s Grandstar Realty Private Limited and the IRP in compliance with Section 18 (c) of Insolvency and Bankruptcy Code, 2016 constituted the Committee of Creditors.

And whereas vide e-voting concluded on 18.04.2024 on the agendas placed in second CoC meeting dated 12.04.2024, Mr. Jalesh Kumar Grover having IP Regn. No. IBBI/IPA-001/IP-00200/2017-18/10390 has been appointed as Resolution Professional.

And whereas after the constitution of the Committee of Creditors dated 20.03.2024, RP had received additional 15 Claims from the Financial Creditors-Home Buyers, which have been verified subject to reconciliation with limited available books of accounts of the Akme Projects Limited.

And whereas, recently around 90 Home Buyers have approached the RP claiming Delay Compensation for the period of delay caused by the Corporate Debtor in handing over the possession to the Home Buyers as per the **Article 4 titled as Possession** in the Flat Buyer Agreement. That in pursuance of this, Home Buyer's claim for delay compensation along with the interest @8% p.a. on delay compensation has been calculated in accordance with provisions and dates of execution of respective Home Buyer's Flat Buyer Agreement till the initiation of the CIRP date i.e. 26.09.2023.

And whereas Section 21(2) of IBC, 2016 specifies that the Committee of Creditors shall comprise of all the Financial Creditors of the Corporate Debtor provided that a Financial Creditor or Authorized Representatives of the Financial Creditor *referred to in sub-section (6) or sub section (6A) of Section 21 sub section (5) of Section 24*, if it is related party of the Corporate Debtor shall

not have any right of representation, participation or voting in a meeting of the Committee of Creditors. Further, the proviso shall not apply to a Financial Creditor, regulated by a financial creditor Regulator, if it is a related party of the Corporate Debtor solely on account of conversion or substitution of debt into equity shares or instruments convertible into Equity Shares or completion of such transactions as may be prescribed, prior to the insolvency commencement date.

And whereas reconstitution of committee of creditors and determination of their voting rights in proportion of claims admitted as per section 21 of Insolvency & Bankruptcy Code, 2016 & Regulation 17 of IBBI (CIRP) Regulations, 2016 was placed before CoC in 13th CoC meeting for approval and same was approved vide e-voting results dated 03.04.2024.

And therefore, in view of the above provisions and as approved by CoC in the 13th CoC meeting dated 25.10.2024 and adjourned to 2nd day and held on 26.10.2024, I, Jalesh Kumar Grover, bearing IP Regn. No. IBBI/IPA-001/IP-P00200/2017-18/10390, Resolution Professional, hereby reconstitute Committee of Creditors on 22.10.2024 on account of receipt and verification of claims received from Financial Creditors in the class of homebuyers in the matter of M/s Grandstar Realty Private Limited.
